

Designed to remove the fear and stigma attached to reporting issues; The Student Voice is an interactive and child-friendly reporting tool that utilises interactive maps of all the contexts that your young people spend time in, so your school or college can improve these spaces with more targeted and effective interventions, and ultimately prevent future harm.

Whether a young person travels on the bus with peers, sees issues happening in the local park, or has a quiet and safe space they prefer in school, students can rank how safe they feel in the spaces they spend time in using a universal traffic light system and report their experiences in these contexts.

Inspectors value that it is consistent and embedded into the **everyday culture of students' lives.**"







Contextual Response


School engaged with the local police to provide safety workshops for students, including how to pre-empt issues and where to find immediate safety should an incident occur.



CONCERNS REPORTED	ACTIONS TAKEN BY SCHOOL
Climate Change	School being a greener and more eco-friendly school will become part of the Schools 3-year strategic plan.
Extremism / Nationalism	Embedding a quality assurance process for students to verify all resources from the Internet is a school-wide expectation.
Sexual Harassment	Targeted support and education for both the perpetrators and impacted students of this behavior.
Radicalised Behaviour	Targeted PSHE programme to address misogynistic views from popular influencers such as Andrew Tate.





Hotspot Mapping






